**Summary:** Would express the intent of the Legislature to enact legislation that would facilitate the transition of foster youth from high school to postsecondary education.

# AB 74 (Calderon D) Care facilities: regulatory visits.

Calendar: 3/24/2015 Anticipated Hearing ASSEMBLY AGING & L.T.C., Not in daily file.

**Summary:** Current law requires the State Department of Social Services to conduct an annual unannounced visit for care facilities under specified circumstances, including when a license is on probation, and to conduct annual unannounced visits to no less than 20% of the facilities, other than foster family homes, that are not subject to an inspection under those specified circumstances. This bill would make every facility of the types described above, except for, subject to an annual unannounced visit by the department on and after July 1, 2018. The bill would revise the provisions requiring the department to conduct annual unannounced visits to no less than 20% of the facilities by instead requiring the department to conduct annual unannounced visits to no less than 30% of facilities on or before July 1, 2016, and no less than 20% of those facilities on or before July 1, 2017.

The bill would require an educational liaison for foster children to ensure that public notice of the educational rights of foster children developed by the department is disseminated or posted in a public area at schools where pupils that are foster children

**Summary:** Would expressly authorize a parent or legal guardian to make a video or audio recording of his or her interview or interactions with a county child protective services social worker who is investigating allegations of parental abuse or neglect. This bill would require such a county child protective services social worker to inform a parent or legal guardian, in writing, that the parent or legal guardian may make a video or audio recording of his or her interview or interactions with a county child protective services social worker.

# AB 424 (Gaines, Beth R) Court appointed child advocates: wards.

**Summary:** Current law provides that a minor, under certain circumstances, is subject to the jurisdiction of the juvenile court. If the minor has violated a law or ordinance, existing law authorizes the juvenile court to adjudge the minor to be a ward of the court. This bill would authorize the appointment of a Court-Appointed Special Advocate in a juvenile delinquency proceeding, and would provide that a CASA shall be considered court personnel for purposes of inspecting the case file of a dependent child or ward of the juvenile court.

**Summary:** Current law requires that minors under the jurisdiction of the juvenile court as a consequence of delinquent conduct receive care, treatment, and guidance that is consistent with their best interests, that holds them accountable for their behavior, and that is appropriate for their circumstances. This bill would make technical, nonsubstantive changes to that provision.

**Summary:** Current law provides that the order and findings of the superior court in each case under the provisions related to juvenile court proceedings shall be entered in a suitable book or other form of written record kept for that purpose and known as the "juvenile court record." # AB 710 (Brown D) Youth on probation: local control funding formula: local control and accountability plans.

**Summary:** Current law requires funding pursuant to the local control funding formula to include, in addition to a base grant, supplemental and concentration grant add-ons that are based on the percentage of certain categories of pupils, known as unduplicated pupils, served by the county superintendent of schools, school district, or charter school. This bill would include a youth who is on

probation, as defined, as an unduplicated pupil. This bill contains other related provisions and other existing laws

# AB 719 (Campos D) Child welfare agencies: missing foster children.

**Calendar:** 4/14/2015 1:30 p.m. - State Capitol, Room 437 ASSEMBLY HUMAN SERVICES, CHU, Chair **Summary:** Would require a county child welfare agency that becomes aware that a child in foster care is missing to report the incident to the police department or sheriff's department and the National Center for Missing and Exploited Children. By imposing this duty on county child welfare agencies, this bill would impose a state-mandated local program. This bill contains other related provisions and other existing laws.

# **AB 741** (Williams D) Medi-Cal: comprehensive mental health crisis services.

Location: 3/12/2015-A. HEALTH

**Summary:** Current law provides for a schedule of benefits under the Medi-Cal program, which includes early and periodic screening, diagnosis, and treatment for any individual under 21 years of age. This bill would add to the schedule of benefits comprehensive mental health crisis services, including crisis intervention, crisis stabilization, crisis residential treatment, rehabilitative mental health services, and mobile crisis support teams, to the extent that federal financial participation is available and any necessary federal approvals have been obtained.

#### AB 801 (Bloom D) Postsecondary education: Success for Homeless Youth in Higher Education Act.

Location: 3/12/2015-A. HIGHER ED.

**Summary:** Would enact the Success for Homeless Youth in Higher Education Act. The bill would extend a specified priority requirement, with respect to the California State University and community college districts, and would extend the request for the granting of priority, with respect to the University of California, to include homeless youth and former homeless youth, as defined, and extend the existence of this provision until January 1, 2020. To the extent that this provision would impose new duties on community college districts, it would constitute a state-mandated local program.

**Calendar:** 4/14/2015 1:30 p.m. - State Capitol, Room 437 ASSEMBLY HUMAN SERVICES, CHU, Chair **Summary:** Would require a recovery house that is owned or operated, as defined, by a community care facility licensed pursuant to the California Community Care Facilities Act and that functions as an integral component of that community care facility to be deemed a facility that provides treatment or services under the license of the community care facility. The bill would subject a facility under that license to the inspection and enforcement provisions of the act. This bill contains other related provisions and other existing laws.

**Summary:** Would authorize a county office of education, or consortium of county offices of education, to apply to the Superintendent for grant funding, to the extent funds are available, to operate an education-based foster youth services program to provide educational support for pupils in foster care. This bill contains other related provisions and other existing laws.

# AB 878 (Eggman D) Child welfare: foster care.

**Location:** 2/26/2015-A. PRINT

**Summary:** Current law establishes the Aid to Families with Dependent Children-Foster Care (AFDC-FC) program, under which counties provide payments to foster care providers on behalf of qualified children in foster care. The program is funded by a combination of federal, state, and county funds, with moneys from the General Fund being continuously appropriated to pay for the state's share of

AFDC-FC costs. This bill would make technical, nonsubstantive changes to those provisions. This bill contains other current laws.

### AB 879 (Burke D) Juveniles: court proceedings: notice.

Location: 3/16/2015-A. JUD.

**Calendar:** 4/7/2015 9 a.m. - State Capitol, Room 4202 ASSEMBLY JUDICIARY, MARK STONE, Chair **Summary:** Current law requires the court to conduct various hearings regarding children who are, or who may become, dependent children, including a detention hearing, jurisdictional hearing, and dispositional hearing. Current law requires the probation officer, the social worker, or the clerk of the court to provide notice of those hearings to certain persons, including parents, guardians, the child, if he or she is 10 years of age or older, adult relatives under certain conditions, and attorneys for the parents or guardians, as specified. This bill would allow service for the above purposes to be made by electronic mail if the county, or city and county, and the court choose to permit service by electronic mail and the person to be served has consented to service by electronic mail by signing a specified form.

**Calendar:** 4/14/2015 1:30 p.m. - State Capitol, Room 437 ASSEMBLY HUMAN SERVICES, CHU, Chair **Summary:** Current law allows a juvenile court to assume dependency jurisdiction over a nonminor former dependent for purposes of participation in the specified programs under the California Fostering Connections to Success Act who has not attained 21 years of age under specified circumstances, including, among others, the nonminor's former guardian or adoptive parent no longer provides ongoing support to, and no longer receives benefits on behalf of, the nonminor after the nonminor turns 18 years of age. This bill would delete the requirement that the parent or guardian no longer receive aid on behalf of the nonminor before a juvenile court may resume dependency jurisdiction.

# AB 891 (Campos D) Low-income youth: educational attainment and success.

**Location:** 3/16/2015-A. ED.

**Summary:** The After School Education and Safety Program Act of 2002 gives priority enrollment in both after school and before school programs to pupils in middle school or junior high school who attend daily. This bill would instead give first priority enrollment to homeless youth, as defined, 2nd priority enrollment to pupils in CalWORKs assistance units, as described, and 3rd priority enrollment to pupils who attend the program daily. This bill contains other related provisions and other existing laws.

# **AB 899** (Levine D) Juveniles: confidentiality of records.

**Location:** 3/16/2015-A. JUD.

**Calendar:** 4/7/2015 9 a.m. - State Capitol, Room 4202 ASSEMBLY JUDICIARY, MARK STONE, Chair **Summary:** Current law requires the case file of a dependent child or ward of the juvenile court to be kept confidential, except as specified. Current law authorizes only certain persons to inspect the case file, including, among others, the attorneys for the parties, judges, referees, other hearing officers, and law enforcement officers who are participating in proceedings involving the dependent child or ward. This bill would provide that nothing in these provisions authorizes the disclosure of juvenile information to federal officials absent a court order upon filing a petition, as specified.

**Summary:** Would state the intent of the Legislature to enact legislation that improves permanency outcomes and stability for older children in foster care by, among other things, providing resources and incentives to counties to improve permanency outcomes for older children and youth in foster care.

**Calendar:** 4/14/2015 1:30 p.m. - State Capitol, Room 437 ASSEMBLY HUMAN SERVICES, CHU, Chair **Summary:** Current law provides that it is the intent of the Legislature that in providing child development programs the Superintendent of Public Instruction give priority to children of families that qualify for public assistance and other low-income and disadvantaged families. This bill would also include homeless families as part of the intended priority for child development programs. This bill contains other related provisions and other current laws.

#### AB 1001 (Maienschein R) Child abuse: reporting.

**Calendar:** 4/7/2015 9 a.m. - State Capitol, Room 126 ASSEMBLY PUBLIC SAFETY, QUIRK, Chair **Summary:** Would prohibit a person from impeding or interfering with the making of a report of suspected child abuse or neglect by a mandated reporter. The bill would provide that an intentional violation of these provisions is a misdemeanor and may subject the offender to liability for actual damages sustained by a victim of child abuse or neglect for any abuse or neglect that occurs after the person impeded or interfered with the report being made. This bill contains other related provisions and other existing laws.

# AB 1025 (Thurmond D) Pupil health: multitiered and integrated interventions pilot program.

Location: 3/19/2015-A. ED.

**Summary:** Would require the State Department of Education to establish a 3-year pilot program to encourage inclusive practices that integrate mental health, special education, and school climate interventions following a multitiered framework in 3 schools in 10 school districts, as specified. The bill would require the State Department of Education to select schools where at least 60% of the student body is eligible for a free or reduced-price meal program and whose applications provide an estimate for the amount of funding being requested for start up and evaluation and detail a model approach that targets the behavioral, emotional, and academic needs of pupils with multitiered and integrated mental health, special education, and school climate interventions.

## AB 1049 (Patterson R) Parent and child relationship.

Location: 3/19/2015-A. JUD.

**Summary:** Current law provides that if a man signs a voluntary declaration of paternity, it has the force and effect of a judgment of paternity, subject to certain exceptions. Existing law provides that these presumptions are rebuttable. This bill would state that a person's offer or refusal to sign a voluntary declaration of paternity may be used as a factor, but shall not be determinative as to the issue of legal parentage in any proceedings regarding the establishment or termination of parental rights.

### AB 1067 (Gipson D) Child welfare.

**Location:** 2/26/2015-A. PRINT

**Summary:** Current law declares the intent of the Legislature to preserve and strengthen a child's family ties whenever possible, removing the child from the custody of his or her parents only when necessary for his or her welfare or for the safety and protection of the public. Current law includes various provisions relating to appropriate placement and other services for children in foster care. This bill would make technical, nonsubstantive changes to those provisions.

# AB 1166 (Bloom D) Pupils in foster care: pupils who are homeless children or youth: school transfer: exemption from local graduation requirements.

**Location:** 3/23/2015-A. ED.

**Summary:** Current law requires the school district to notify specified individuals, including a pupil in foster care or a pupil who is a homeless child or youth, within 30 calendar days of the date that a pupil who may qualify for the exemption from local graduation requirements transfers into a school, of the availability of the exemption and whether the pupil qualifies for an exemption. This bill would, if the school district fails to provide that notification, declare the effected pupil eligible for the exemption from local graduation requirements once notified, even if that notification is received after the termination of the court's jurisdiction over the pupil or after the pupil is no longer a homeless child or youth, as applicable.

### AB 1207 (Lopez D) Mandated child abuse reporting: child day care licensees: training.

Location: 2/27/2015-A. PRINT

**Summary:** Would require the State Department of Social Services to develop and disseminate information to those persons regarding detecting and reporting child abuse, and to provide statewide guidance on the responsibilities of those persons as mandated reporters, as provided. The bill would require those persons, as a condition of licensure, to complete training pertaining to these matters, as provided. By creating a new crime, this bill would impose a state-mandated local program. The bill would make conforming changes. This bill contains other related provisions and other existing laws.

# AB 1225 (Weber D) Housing: former nonminor dependents: homeless youth.

Location: 3/23/2015-A. HUM. S.

**Summary:** Current law makes transitional housing available to any foster child who is at least 16 years of age and not more than 18 years of age who is eligible for AFDC-FC benefits, any nonminor dependent who is eligible for AFDC-FC benefits, and any former foster youth who is at least 18 years of age and not more than 24 years of age who has exited from the foster care system and has elected to participate in the Transitional Housing Program-Plus, as defined, if he or she has not received services pursuant to these provisions for more than a total of 24 months. This bill would additionally make transitional housing available to any former nonminor dependent with special needs and any homeless youth.

### AB 1228 (Gipson D) Public postsecondary education: campus housing: priority for homeless youth.

Location: 3/23/2015-A. HIGHER ED.

**Summary:** Current law requests the Regents of the University of California and the Trustees of the California State University to explore methods of using the admissions-by-exemption category to assist the transition of students in foster care into 4-year public institutions of higher education. This bill would request the regents and the trustees to provide that assistance to students who are homeless youth.

**Summary:** Would update statutory references to the Workforce Investment Act of 1998 to instead refer to the Workforce Innovation and Opportunity Act of 2014 and make related conforming changes. This bill contains other related provisions and other existing laws.

# AB 1299 (Ridley-Thomas D) Medi-Cal: specialty mental health services: foster children.

Location: 3/23/2015-A. HUM. S.

**Summary:** Would declare the intent of the Legislature to ensure that foster children who are placed outside of their county of original jurisdiction, are able to access mental health services in a timely manner consistent with their individualized strengths and needs and the requirements of Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) program standards and requirements. The bill would require the tate Department of Health Care Services to issue policy guidance that establishes the presumptive transfer of responsibility for providing or arranging for mental health services to foster youth from the county of original jurisdiction to the foster child's county of residence, as prescribed.

#### **AB 1327** (Dahle R) Foster care: transitional housing.

**Location:** 3/23/2015-A. HUM. S.

**Summary:** Transitional housing may, if the State Department of Social Services provides approval, include programs in which a participant lives independently in certain types of housing owned or leased by provider under the supervision of the provider. This bill would delete the requirement that the housing be owned or leased by the provider and would instead require that a provider be responsible for the payment of any contracted rental fees and any penalties for late payment to the

**Summary:** Would require the State Department of Social Services, in consultation with the County Welfare Directors Association, foster parents, caregivers, and current and former foster youth, to develop and implement a foster parent evaluation process. The bill would require that evaluation process to include a process to allow foster youth over 12 years of age and nonminor dependents to provide feedback on the quality of care received in licensed or certified foster homes and group homes at least once per year and upon any exit from those homes.

This bill would make conforming changes to allow a court to assume or resume dependency jurisdiction or transition jurisdiction over a nonminor who satisfies this criteria. Because the bill would expand the application of the above county administered programs, the bill would impose a state-mandated local program. This bill contains other related provisions and other existing laws.

# **SB 68** (Liu D) Minor parents: reunification services.

Location: 2/5/2015-S. JUD.

**Summary:** Current law prohibits the court from ordering reunification for a parent or guardian described under specified provisions, unless the court finds, by clear and convincing evidence, that reunification is in the best interest of the child. This bill would instead require the court to order reunification services for a parent described under those provisions if the parent was a minor at the time when the facts that gave rise to the condition for the court to deny reunification services occurred. Because providing reunification services imposes additional duties on social workers and other county employees, the bill would impose a state-mandated local program.

secure state or local juvenile facility from being subject to solitary confinement unless certain conditions are satisfied.
