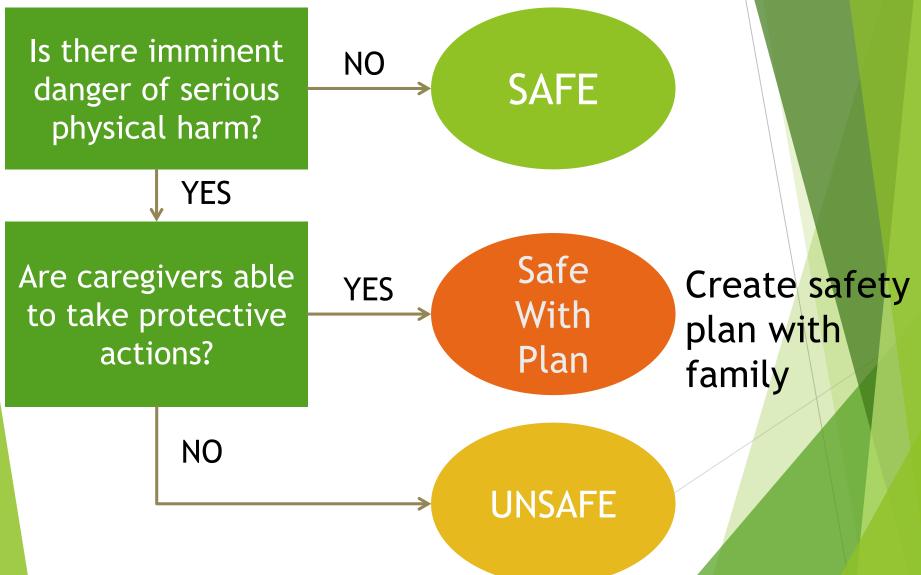

SDM and Safety Threats



Engagement Opportunities Use SOP and SDM Ask the to guide next questions question Ask the next question Listen to their story

Engagement

PSW introduces self and explains she is there to investigate a report received about a domestic violence incident in the home.

OR

PSW introduces self and explains she/he is going to ask a bunch of questions and then TOGETHER THEY can figure out next steps to keep the kids safe. PSW explains CWS's goal is to help parents build safety for their kids. PSW establishes need for open honest communication so TOGETHER they can make decisions that will be in the kid's best interest.

THE POWER OF ENGAGEMENT

"How did you get the bruises on your face and arms?

or

"Was there a time when a DV incident almost happened, but you were able to protect yourself and your children were not exposed to any violence? What was different that time?"

Including the voice of the child

The purpose of interviewing children is to assess the impact of their parent's behavior on them and to include the child's voice in your assessment.

PENAL CODE § 11165.6 DEFINITION OF CHILD ABUSE OR NEGLECT

CHILD ABUSE AND NEGLECT

Physical injury or death inflicted by other than accidental means upon a child by another person

Unlawful corporal punishment of a child

The willful harming or injury of a child

The endangerment of the person or health of a child

Neglect

Sexual Abuse

Did Abuse or Neglect occur?

THE PENAL CODES DEFINE ABUSE AND NEGLECT

Sexual Abuse PC § 11165.1

General/Severe Neglect PC § 11165.2

PC § 11165.3 and 11166.05

Physical Abuse/Willful Harming of a Child PC § 11165.3 and .4

What does the evidence tell us? PENAL CODE 11165.12

Substantiated

 Credible evidence that makes it more likely than not that child abuse, neglect or exploitation occurred.

Inconclusive

 Not "unfounded" but findings are inconclusive and without enough info to determine if abuse, neglect or exploitation occurred.

Unfounded

 Determined to be false, an accidental injury or not constituting child abuse.

Interventions

- Close referral and provide referrals
- Voluntary
- ► File a petition in Juvenile Court

Need for Referrals to Services

- A restraining order is needed to keep a mother safe at home with her child.
- A landlord/tenant issue is jeopardizing a family's stable housing.
- A relative needs a guardianship to establish permanency.
- A parent on probation has an outstanding warrant and a heightened risk of reincarceration.
- A parent in recovery needs help finding a new sponsor.
- Language or literacy issues are preventing a parent from finding consistent employment.

Voluntary Case Plan under WIC 301

- Substantiated allegation of abuse or neglect
- Moderate to high risk
- Family willing to work with Agency
- Substantial risk child will enter foster care
- 6 months—can be extended to 12 months in certain situations

Is Court Intervention needed?

Is there sufficient evidence to support risk of future harm?
